Park Hill School District is receiving bid proposals for one (1) 30-Gallon Tilting Braising Pans as per the attached specifications to furnish and deliver to Park Hill South High School. Bids will be accepted at the Food Service Department Office, 8500 NW Riverpark Drive, Pillar 116, Parkville, Missouri 64152, until 9:00 a.m., Wednesday April 5, 2017, at which time the bid is publicly opened and is made part of public record of the Park Hill School District. It is not the policy of Park Hill School District to purchase on the basis of low bids alone, quality and suitability to purpose being the controlling factors. That being understood, the purchaser reserves the right to arrive at such by whatever means he may determine.

Deviations in product will be considered an alternate bid which must be noted to Park Hill School District prior to the bid opening and may be rejected at the discretion of the Park Hill School District. **Failure to follow any of these instructions will disqualify the offer.**

**This bid form must be used and all bids are to be signed below. Bids need to be submitted on the bid sheet form provided in a sealed envelope marked “30-Gallon Tilting Braising Pan”. Failure to follow any of these instructions will disqualify the offer. Faxed or e-mailed submissions will not be accepted. It is the bidder’s responsibility to ensure delivery of bid by the deadline specified.**

This Bid is a firm offer which shall be irrevocable and open for acceptance for 45 calendar days from the day set for submission of bids. **SPECIAL REQUIREMENTS**

1. Bidders are required to read entire bid document. Please pay close attention to the bid that is being submitted.
2. Bids must be submitted only on the form provided in this bid document. All information must be legible. Any and all corrections and/or erasures must be initialed. All required information must be provided.
3. The following terms and conditions shall prevail unless otherwise modified by the Park Hill School District within this bid document. Park Hill School District reserves the right to reject any bid that may take exception to these terms and conditions.

## TERMS AND CONDITIONS

**CHANGES** - Any changes to the requirements specified herein will be communicated to all bidders by the issuance of an addendum. All bidders shall comply with the requirements specified in any addendum issued by Park Hill School District.

**DAMAGES** – The successful bidder will be held responsible and required to make good (at their expense), all damages to persons or property caused by the bidder’s employees and/or agents.

**PAYMENTS** – Terms are net forty-five (45) days. When multiple school sites are included on the bid, each site must be invoiced separately for their equipment unless otherwise stated.

**TAXES** – Park Hill School District is tax exempt, so bid should reflect this status.

**SCOPE** - The intention of this bid is to solicit bids for Park Hill School District equipment. **Once awarded by the District, this bid pricing and terms are to remain in place for four months from the initial bid opening date and additional equipment purchases of the same items may be made utilizing this bid solicitation.**

### FELONY CONVICTION NOTIFICATION

**“The person or business entity that enters into an agreement with this school district must give advance notice to the District if the person or an owner or operator of the business entity has been convicted of a felony. The notice must include a general description of the conduct resulting in the conviction of a felony”.**
