<p>To meet Fall 2018 MSHSAA eligibility requirements, all students taking high school summer school credit recovery courses must physically attend summer school for the entire 120-hour program and successfully complete the course including required final and End of Course exams. If the student successfully completes the credit recovery course prior to the last day of summer school, the student must continue to attend summer school each day and will be provided additional educational materials to complete. <u>Failure to attend all 120 hours of the credit recovery program will result in ineligibility for the Fall 2018 semester under MSHSAA guidelines.</u> Credits earned or completed after the close of the semester will not fulfill this requirement. Summer high school courses for Fall 2017 academic eligibility may count provided the course is necessary for graduation or promotion (no electives), and credit is placed on the school transcript. No more than one unit of credit in summer school shall be counted toward eligibility. Correspondence courses may not be used to re-establish academic eligibility.</p>
